Agreement to Provide a Software Engineer Job in U.A.E.

This agreement is made and effective from date <u>17.12.2011</u>

NOW, THEREFORE, in consideration of the mutual agreements and covenants herein contained the parties here to agree as follows:

- 1. **Main Task:** First party will provide second party a Software Engineer Job in UAE in its organization. For this First Party will charge a fee of Rs 300,000 (Indian Rupees Three Lakhs Only) from second party.
- Payment Terms: In Two Installments Second Party can Pay to First Party.
 Installment 1: Rs 100,000 (Rupees One Lakh) after Receiving an Offer Letter from First Party.
 Installment 2: Rs 200,000 (Rupees Two Lakhs) after Receiving an Employment Visa and Air Ticket.
- 3. **Execution Plan:** Employment visa with profession as Computer Programmer / Computer Engineer will be provided within 15-25 working days (Degree certificate attestation 10 days, Visa processing 15 days) from the date of receiving first installment. For those who don't have degree in hand (Employment visa will be provided in 15 working days) and want to join immediately, we can process their visa on non technical profession, later they can change it to technical with their own expenses when the attested degree is ready. One time visa and one ticket expenses are included in the fee.
- **4. Qualification of Second Party:** MCA/B.Tech/BE/BCA with minimum 60% (Certificate should be genuine and should pass the attestation process of Indian and UAE govt.).
